When explaining conditions that might delay emergency response, please be specific.

Having advance knowledge of special needs saves time during life-threatening emergencies. The responding units can better serve the citizens when they are aware of any special equipment or personnel that may be needed to handle the special need.

House numbers should be posted so they are visible from the road from both directions both day and night. If your mailbox is not in front of and on the same side of the street as the residence, it should not be the only place your house number is posted.
