DOOR TO DOOR SOLICITATION GENERAL INFORMATION

- Applicant **MUST** have a valid business license (occupational certificate) before a solicitation permit will be issued.
- Applicant **MUST** be an employee of an existing business with a valid business license, or must apply for their own Business License.
- All persons soliciting (even those just driving) must have a solicitation permit.
- Photo ID is required on all applicants for solicitation permits.
- Applicants must be 18 years of age at time of application
- Applicants must be US citizen or legal alien at time of application
- Permits issued for 2 weeks only, may only be renewed once per calendar year for an additional 2 weeks
- Must obtain State Peddler's License before applying for Hall County Solicitor's permit
- Fingerprints and background investigations are required on all applicants
- May not enter into neighborhoods, areas or homes where signs prohibiting solicitation are posted.
- Must wear Hall County issued ID badge and must show other ID when requested.
- Only one person may solicit at any one location at any time.
- Hours approved for solicitation are between 9 – 5 daily. No Sunday or holiday solicitation
- May **NOT** place anything in or onto a mailbox or mailbox post, leave anything on a door/porch, or throw anything into yards of private residences (littering).
- Fees are \$100 per person (payable in cash or money order **ONLY**), renewal within a calendar year \$50.00. Must re-apply for new licenses/permits each year.
