This is an amendment and a correction to report ref # 59189 which i completed yesterday 10/22/18.

Per further clarification, by DeptManager Mark Murrah, of the Animal Protection Rule on the minimum age to sell or adopt animals, puppies must be 8 weeks old prior to sell by pet stores and per dealers. However, a GDA licensed animal shelter can adopt out puppies under 8 weeks old as long as the shelter follows the requirments of the rule:

"Written recommendations for the appropriate feeding and care must be provided at the time of the transaction for those animals that are not independent of parental nurturing."

This means that Hall Co Animal Shelter can, by rule, adopt out puppies under 8 weeks old as long as provide written care instructions for "animals thar are not independent of parental nuturing."
